Trailer Parking- follow signage. Clear Creek Elementary-on the corner of S. 12th St and 9th Ave S. Right from the CLYC-2 blocks on South Shore Drive. Take a left and proceed .3 miles to stoplight-take a right. .3 miles through 2 stop signs -left into parking lot.

Spectators- boat pick up on city dock to the Right (west) of the CLYC available on Friday-please communicate with your driver for rides on Sat and Sunday.

Eligibility- Members of the clubs at Calhoun, Clear Lake, Harriet, Lotawana, Minnetonka, Okoboji, Upper Minnetonka and White Bear Lake. Each lake may send an unlimited number of boats for E,C,MC and X fleets. Boats designated as top 5 on the registration form provided by each club in each fleet will count toward the Inter-Lake team scoring trophies and all entrants are eligible for individual Inter-Lake awards.

Fees- E=\$100, C=\$80, MC=\$70, X=\$60. Club fee=\$100and Fleet fee\$20 per fleet.

Racing-Six races are planned. Friday 3, Sat 2, Sunday 1. Races covered by The Racing Rules of Sailing 2017-2020. One race constitutes a regatta.

Scoring- Team scoring uses the simplified low-point system as modified in the Inter-Lake Yachting Association By-laws; individuals use the RRS 2017-2020 low point scoring system. The right of appeal is denied.
